

(iii) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

1. PRESIDENT:

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case a tie in decision making. He can supervise all branches as the Society.

2. VICE-PRESIDENT:

He shall assist the President in discharge his functions. In the absence of the President he will per form the duty of the President as entrusted by the President.

3. SECRETARY:

He is the Chief Executive Office of the Society and Custodian of all records relating to the Society and correspondent on behalf of the Society. He has to take on record all minutes of the Society, Would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasure in preparing the budget and expenditure statement to place before the General Body for its approval.

He is responsible for all-financial transaction and funds of the society. He has to maintain accounts of the club

4. JOINT SECRETARY:

He has to do the work entrusted by Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.

5. TREASURER:

He has to maintain account properly along with the vouchers. He has to prepare the accounts of the Society under the guidance of the Secretary or President.

6. OFFICE BERAREERS:

They are responsible persons to attend to such activities of the society, which the Executive committee entrusts to them.

7. QUORUM:

Half of the total members for General Body meeting and ¼ for Executive Committee meeting.

B. FUNDS:

That the funds shall be spent only for attachment of the objects of the Society and no portion there of shall be paid to transferred directly or indirectly to any of the members through any means.

9. AMENDMENTS:

No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/8 of its members present at a special meeting convened to be purpose and confirmed by 2/3 of the members present and at a second special meeting.
